- iv. निर्धारित अन्तिम तिथि के पश्चात निविदा स्वीकार नहीं की जायेगी।
- v. अग्रधन की राशि - ₹10,000/- (दस हजार रुपये)।
- vi. सेवा/सामग्रियों का आपूर्ति आदेश प्राधिकरण कार्यालय द्वारा दिया जायेगा।
- vii. इस संबंध में आवश्यक प्रक्रिया, शर्तों आदि की जानकारी तथा सामग्री/सेवा की सूची, मात्रा/गुणवत्ता का विस्तृत विवरण बिहार राज्य आपदा प्रबंधन प्राधिकरण के वेबसाइट [www.bsDMA.org](http://www.bsDMA.org) पर देखा जा सकता है।

**Short Term Notice Inviting Tender**

**For Empanelment of Agency for Sonepur Mela-2019**

The Secretary, Bihar State Disaster Management Authority, Govt. of Bihar (BSDMA), invites sealed Tender (Two Bid System) from reputed and experienced agency/contractor for rate contract for empanelment of the Agency/Contractor for Sonepur Mela-2019 (to be continued for one month.)

Tender shall be submitted by interested agencies in an outer sealed non-transparent envelope superscribed with "NIT for Empanelment of Contractor / Agency for Sonepur Mela-2019, name of the agency and contact no./ email-id of the agency". The outer envelope shall contain the following two sealed non-transparent envelopes:-

- A) Envelope- I: Marked as Technical Bid
- B) Envelope- II: Marked as Financial Bid

Each envelope (Technical Bid & Financial Bid) should be marked with "NIT for Empanelment of contractor/agency for Sonepur Mela-2019, name of the agency and name of Bid (Technical or Financial)". An EMD (Earnest Money Deposit) of Rs. 10,000/- (Rs. Ten Thousand Only) in the form of a Demand Draft drawn from a Scheduled Bank/Nationalized Bank of India, in favour of "Secretary, Bihar State Disaster Management Authority" payable at Patna must be enclosed with the Technical Bid.

If the envelope is/are not sealed and marked properly, the tendering authority will assume no responsibility for disqualification. Incomplete response or those received after the specified time and date or not fulfilling the specified requirement shall not be considered.

Financial Bid of only those bidders, who have qualified the technical eligibility criteria shall be opened on the date and time as specified above.

The undersigned reserves the right to issue addendum/ corrigendum, to accept or reject any or all proposal, or to cancel the whole NIT at any stage without assigning any reason thereof.



**Eligibility criteria, Term & Conditions, Payments guidelines etc  
for Empanelment of Agency for Sonepur Mela-2019**

**1. Pre Bid Meeting**

A Pre Bid meeting with bidders is scheduled on 15 October 2019 at 3.00 PM in the Office of BSDMA. After Pre Bid meeting, if necessary, a corrigendum may be uploaded on our website for further direction to the prospective tendering agencies.

**2. Bid Validity Period**

The Bid Validity Period will be 180 days from the last date of submission of this tender.

**3. Earnest Money Deposit (EMD)**

Refundable Earnest Money shall be deposited as indicated in the "Notice Inviting Tender" failing which the Bids submitted by the agency shall be out-rightly rejected.

3.1 No interest will be payable on the amount of EMD irrespective of the outcome of tendering process.

3.2 The EMD of unsuccessful bidder will be returned after expiry of Bid validity period or issue of Letter of Award (LOA) and submission of performance guarantee by successful bidder, whichever is earlier.

**4. Performance Guarantee (Non-Interest bearing)**

4.1 The successful bidder has to submit performance guarantee (PG) of Rs. 30,000/- (Thirty Thousand only) in the in the form of a Demand Draft drawn from a Schedule Bank/Nationalized Bank in favour of " Secretary, Bihar State Disaster Management Authority" payable at Patna failing which the EMD shall be forfeited. The EMD of successful bidder may be adjusted into the Performance Guarantee and the DD of balance Rs. 20,000/- has to be submitted. The Performance Guarantee will be released after two months from the date of end of contract.

4.2 Performance Guarantee can be forfeited and the LOA may be cancelled, if the successful bidder fails to supply the items within the stipulated time/quantity/quality as given in the work order and to the satisfaction of BSDMA. The decision of Secretary, BSDMA will be final and conclusive in this regard.

5. Before finalizing the tender, the premises/facilities of the bidder may be inspected by the internal purchase committee.

6. Conditional tender shall not be considered.



**7. Minimum Eligibility Criteria & required documents with technical bid:-**

Note:

- (I) The Financial Bid of only those bidders will be opened, who will pass the above “Minimum Eligibility Criteria” under Technical Evaluation.
- (II) The successful agency has to take such corresponding registration as required under New GST Laws.


**8. Bid Price and Evaluation of Financial Bid and Letter of Award (LOA)**

- 8.1 All taxes and other charges like transportation etc. shall be included in the Quoted Rates and shall be written in the blank space specified on APPENDIX-I. However, in the Invoice, Tax (es) has to be shown separately. Nothing will be paid over and above the quoted price under any circumstances.
- 8.2 No request relating to advance payment of the ordered materials will be entertained.
- 8.3 The price should be quoted in Indian Rupees only.
- 8.4 Taxes will be deducted at source as applicable.
- 8.5 The bidder shall quote for all of the items as mentioned under Financial Bid. L-1 bidder will be evaluated on the basis of total cost and will be so selected.
- 8.6 BSDMA will issue Letter of Award (LOA) to the successful bidder.
- 8.7 Work orders will be issued upon requirement only. Selection of bidder under the RFQ or Issuance of LOA will not guarantee issuance of work order/s and BSDMA will not assume any liability or cost towards it.
- 8.8 Items will have to be supplied as per the quantity and specification mentioned in the work order. The quality of the items supplied should be as per satisfaction of BSDMA. The supplies have to be made at the site of Sonapur Mela.



Failure on the part of successful bidder to do so may result in cancellation of its LOA/Work Order and their Performance Guarantee may be forfeited. In such case, BSDMA may, at its liberty, negotiate with other bidders (L-2 and so on) for the supplies to be made at L1 prices or at negotiated rates. Also in case of exigencies and volume of supplies, BSDMA may request L2 bidder of respective items and so on to make the supplies at the negotiated rate of L-1 bidder.

- 8.9 The rate quoted shall be valid for one year from the date of issuing of LOA. However, it may be extended further depending upon performance and with mutual consent.
- 8.10 Payment shall be released on submission of bills with copy of work order issued by BSDMA. The satisfactory performance will be the essence under this contract and would need to be executed in the specified time frame and quality as per the work order. BSDMA may also charge penalty up to a maximum of 5% of the payments due, if the performance is not satisfactory. BSDMA may at its discretion can reject whole of the supplies, if they were found to be of extremely inferior quality. In that case, fresh supplies will have to be made at the bidder's own cost. The decision of Secretary, BSDMA will be final and conclusive in this regard.
- 8.11 The continuous unsatisfactory performance may lead to confiscation of performance guarantee and cancellation of LOA. The decision of Secretary, BSDMA will be final and conclusive in this regard.
